

### Holiday Happenings!








Old Glory

## IWCC v. James O'Connell, Individually & Owner of Triple M&B, LLC aka McBrody's Restaurant

On September 25, 2019, the Illinois Workers' Compensation Commission assessed a penalty of \$1.3 million against the owner of a restaurant/bar located in Joliet, IL. Mr. O'Connell and his wife operated restaurant/bar a called McBrody's in downtown Joliet for 11 years. Mr. O'Connell operated his business without workers' compensation insurance. In 2014, the Insurance Compliance Division brought a noncompliance action against Mr. O'Connell for his failure to carry workers' compensation insurance.

In August 2014, Mr. O'Connell agreed to pay a minimum fine of \$10,000 to settle the non-compliance case. He was to pay his fine over several months. Instead of making payments, Mr. O'Connell defaulted on his payment agreement, despite several attempts to get him to abide by his payment agreement. Finally, Insurance Compliance Division took the matter to hearing. Mr. O'Connell failed to appear at any of the hearings before the Workers' Compensation Commission.

In September 2019, the Commission found that Mr. O'Connell, individually and as owner of the McBrody's Restaurant had knowingly failed to obtain workers' compensation insurance for a period of 2,764 days and fined him the maximum penalty of \$500 per day for each day of non-compliance or nearly a \$1.4 million penalty.

#### Insurance Crime

The National Insurance Crime Bureau recently referred a case to the Insurance Compliance Division for investigation. The case involved a down-state company that produced nails and drill bits. This manufacturing company had allowed its workers' compensation insurance to lapse. Unfortunately, one of its workers suffered a work-related injury during the time the company was uninsured.

When the injured worker filed a workers' compensation claim with the Workers' Illinois Compensation Commission (IWCC), the owner of the company submitted the claim under the workers' compensation policy for a company owned and operated by his wife. The insurance carrier for the wife's company investigated the claim and denied the claim when it determined that the worker did not work for the wife's company but worked for the nails and drill bits company. The insurance carrier reported the case to the National Insurance Crime Bureau. The Bureau reported the case to the Insurance Division. After our Compliance investigation, we assessed a \$100,000 fine against the manufacturing company for its failure to be properly insured.

#### FAO'S

\* How many employees do I need before I am required to get workers' compensation insurance?

If the employer has one employee, even a part-time employee, the employer must provide workers' compensation insurance.

I am just getting my new company off the ground. Is there a grace period, before I have to get workers' compensation insurance for my employees?

No. As soon as your first employee starts working, you have to cover that employee with workers' compensation insurance.

Can an employee be fired for reporting an accident or filing a workers' compensation claim?

It is illegal for an employer to harass, discharge, refuse to rehire, or discriminate in any way against an employee for exercising his or her rights under the law. Such conduct by the employer may give rise to a separate suit for damages in the circuit court. However, if an employee, with a pending workers' compensation claim, may still be disciplined or fired for other valid reasons.
